



The Borough President is tasked by the New York City Charter to select community board members whose demographic characteristics reflect the population of the borough's 18 community districts. Borough President Reynoso extended the Charter mandate to include those employed in health, creative, technology, and trade sectors as well as users of various transportation modes. A cornerstone of the Borough President's plan for community boards is increasing the number of younger members and appointing members who reflect the districts' diversity. Fully representative community boards are aligned with the Borough President's vision for an equitable Brooklyn.



## THE VISION

# THE APPOINTMENT PROCESS

The 2023 appointment process officially began on November 15, 2022, with the Brooklyn Community Board application going live on the Borough President's website for online or paper submission. The deadline originally set as February 14 was extended through February 23, 2023. Paper submissions were accepted either by mail or hand-delivery to Borough Hall. The application contained standard questions to establish identity and residence. Applicants could also choose to self-identify based on demographic categories related to housing, transportation, education, race, and ethnicity. Applicants were also asked to submit a statement of interest.

The Borough President's staff scheduled interviews with new applicants as well as reapplicants who attended less than half the required board meetings. Staff designed two interview screens containing numerically valued questions. The "new applicant" screen ascertained ties to the community district, involvement with volunteer or service organizations, relevant skill sets, and interests. The "reapplicant screen" assessed whether the members with low attendance retained an interest in remaining a board member and their future ability to contribute. Questions explored knowledge of board decisions and commitment to continuing membership.

#### **APPOINTMENT PROCESS (CONTINUED)**

Tity Council Members were given restricted access to the database to review applications. Uprior to meeting with the Borough President's staff to select their nominees for appointment. Borough President Reynoso generally deferred to Council Member recommendations.

Borough President Reynoso reviewed the staff's interview notes and made final selections based on a combination of interview score, diversity (assessed by comparing applicants' demographic profile to district demographic information readily available on the Department of City Planning's website), and recommendations from the Council Members and Borough Hall staff.

From a pool of 1,061 unique applications, staff interviewed 597 people including 20 reapplicants, and made 212 first time appointments and 296 reappointments, leaving only six vacant seats across 18 boards. Five of the six seats were left vacant as the recommendations were not submitted by the deadline. One seat will not be filled due to the paucity of applications received for the board.

At the end of the process, the Borough President wrote to congratulate the appointees and extended his appreciation to all applicants for their interest in community boards.


Borough President Reynoso spearheaded a vigorous publicity campaign to reach Brooklynites, specifically targeting youth ages 16-18, young adults, NYCHA residents, and immigrants. The goal was to broaden diversity across socio-economic and geographic populations. Active outreach began in October 2022 with an announcement to all community boards and council members that the application would be live on the Borough President's website starting November 15. The outreach campaign utilized LinkNYC kiosks throughout Brooklyn, in-person and virtual presentations to high schools, colleges, and youth-oriented cultural and educational organizations.

The Borough President also used social media to promote the application, and shared assets with community boards, stakeholders, and community partners including the Brooklyn Public Library (BPL), who then disseminated the information to their networks. Borough Hall staff directly engaged with patrons at the BPL Central Branch. Borough Hall staff contacted 90 youth-focused organizations, including high schools, resulting in 11 applications received from youth (ages 16-19) and six youth appointees. To further promote the application period staff participated in panel discussions with sororities and service organizations and networked with colleges.

Staff also took to Brooklyn streets to poster in businesses and introduce community boards to everyday residents, particularly in areas with historically low numbers of applicants.

One of the most effective outreach efforts was Borough President Reynoso's keen spotlight on community boards in his 2023 State of the Borough address. The Borough President also used his media platform to call for community board applicants and emphasize the need for diversity. The success of the campaign can be measured in the 1,061 applications received, a 28% increase over the 2022 applicant pool. At the end of the appointment cycle, there were only seven vacant seats, a vast difference from 43 in the previous year.

Six of these vacancies will be filled before the end of the fiscal year. In 2022, six boards fell below an acceptable minimum threshold of 40 applications received, with Community Board 11 having the fewest at 19. In 2023, applications received for Community Board 11 increased 89% from 19 to 36. Also noteworthy is a 135% increase for Community Board 9, and a 77.5% increase for Community Board 3. Due to the number of applications received, it will be possible to fill most vacancies that occur in the year ahead.



# THE COHORT

rooklyn's neighborhoods Dembody a sense of place, diverse in its peoples, languages, cultures, geographic layout, and housing stock. Borough President Reynoso is ensuring that our boards reflect the rich tapestry of Brooklyn.

Selected from 1,061 applications, 508 persons were sworn in as members of Brooklyn's 18 community boards. Among the cohort is 341 members who sought reappointment. The cohort is a combination of reappointed and first-time members.

The collection of demographic data is based on information that applicants chose to provide. The data in the report was calculated on the number of responses. As such the analysis does not present a complete picture of the boards.





## AGE

Members over and under 40 at Brooklyn Community Boards






Community board members have historically skewed older than the districts they represent. In 2022, 21% of members were in the under 40-age group. This year there are 107 firsttime members between the ages of 16 and 39 comprising 51% of the newly appointed. As in 2022, they are 21% of the cohort. The younger age of the cohort may be correlated to the 115 members, a 98.3% increase, who are parents of children under the age of 18. Persons 39 and under comprise 26% of all Brooklyn's community board members. Notably six of this year's appointees are aged 16-19.

Community Board 4 has the largest group of members under 40 (46%), followed by CBs 12 (43%), 17 (42%) and 14 (41%). Conversely, the boards with the largest group of members aged 60 and up are CB 15 (59.6%), CB 10 (58%), CB 13 (54.5%).



# **GENDER**



There are 10 more women than men in the newly appointed class which has 106 women,96 men; 6 persons identified as gender non-conforming (GNC). In the 2023 cohort, 50% of members are women, versus 35% in 2022 when 160 women were appointed. Of the 84% who answered, women accounted for account for 43% and men 41% of all Brooklyn community board members.


The 2022 Census records the Brooklyn population as 52.3% women but does not account for those identifying as GNC. There are wide gender disparities across some community boards. Compared to Census data, males are overrepresented by more than 10% in CBs 12 (28%), 15 (27%), and 6 (13%). Women are overrepresented by 10% or more in CBs 13 (by 17%) and 16 (by 20%).

#### The male and female representation at Brooklyn Community Boards compared to 2020 Census.




# HOUSING

housing types between new appointees and the full community board membership



rooklyn residents live in dwellings from houses, apartments, condos, and co-ops across a Dvariety of price ranges. Our community boards reflect this with 69 or (32%) of new members being homeowners while 64 or (30%) are market rate renters. The outreach campaign focused on underrepresented voices, including New York City Housing Authority (NYCHA) residents, home to 102,907<sup>1</sup> (6.9%) of Brooklyn's population. In 2023, 27 new apppointees live in rent regulated housing including 10 NYCHA residents.

The representation of homeowners across Brooklyn community boards inclusive of members who have invested in limited equity housing decreased to 43% in 2023. In a city where affordable housing options are limited, 9.6% of all members live in NYCHA development or rent regulated housing.



The categories in this guestion do not match the Census, however, the Borough President believes it is appropriate to recognize smaller populations whose voices and ability to advocate may be suppressed. As with other demographic questions, response was optional and 33% did not answer. First time appointees identified themselves as African American (40%), White (29%), Caribbean heritage (19%), Latino or Hispanic (14%), East Asian and SE Asian (7%), Pacific Islanders (3%), and (2%) Middle Eastern and Northern African. The cohort contributed to further diversifying Brooklyn's boards, which are now 37% African American or Black, 15% Caribbean, 12% Latino, 10% Asian and 37% white. Comparing the cohort with the 2020 Census data, Latino/a/e/Hispanics are the most underrepresented on Brooklyn community boards by 7%.

The ethnic and racial dispersal varied widely across boards. CBs 12 and 15 have no members who identify as African American, Caribbean, or Sub-Saharan African, while CBs 10 and 11 have a total of three such members between them. Similarly, boards with historically high African American populations, such as CBs 3, 5, 8, 9, 16, 17, and 18, have 50% or more members who identify with these categories. The highest representations of those who identify as Hispanic/Latino are in CB 7 (39%), CB 4 (36%) and CB 1 (22)%. At 14%, CB 16 has the second widest gap in Hispanic/Latino members. Persons from Middle East and North Africa are 2% percent of all board members.


Within the cohort, 56 persons (11.6%) identified as immigrants and 22 members (4.5%) as nonnative English speakers, 9 more than in 2022.







## TRANSPORTATION




ew York City has one of the most extensive public transportation networks and arterial **I N** roadways in the world. Through new state-of-the-art buses and trains, road redesigns and safety initiatives, New York City is encouraging the use of multi-modal options. Board members represent all user types. This year the transportation guestions offered five options to measure the frequency of mode usage. Two categories: - "often" and "mostly" - were combined in the analysis to provide a clear picture of how the new appointees travel through the city.

The bus or train were the most-used options with 78.5% of new members taking either the bus or train as their preferred form of commuting, 12% ride a bike or use a micro-mobility device, and 89.5% walk at least some of the time. Despite the high preference for public transportation, 25% never use public transportation. Paratransit users are 5.7% of members.



# EDUCATION



rooklyn community board members hold undergraduate or graduate degrees at almost twice D the rate as Brooklynites. According to the 2020 census 39.5% of Brooklyn residents had at least a bachelor's degree, compared to 62% of community boards members. The number of members certified in a trade or vocation appointed to community board remained below 1%.

# **EMPLOYMENT**

mong the new cohort, government employees account for just over 23% of members with New York City employees representing 18%. Private sector employees are 19.7%, same as those employed at non-profits. Business owners make up 16%, freelancers are 10% and 16.7% (85 members) are retirees.





# CONCLUSION

n the State of the Borough address, Borough President Reynoso stated that Community Boards are integral to building a better Brooklyn. The Borough President envisions community boards that embody the ideals set out in the New York City Charter. This year's class of community board members advances the goal toward diversity and appointing classes of members that will increasingly mirror the district they serve. The outreach campaign garnered sufficient applications to allow the filling of almost all vacancies. The member selection centered on the awareness that diversity in age, housing, income, ethnicity, and transportation are essential to policy making. The focus remains on diversity with the goal that each class will increasingly mirror the district it serves. Through expertise, trainings, and professional development, board members will be equipped to be knowledgeable advocates building an equitable Brooklyn.

While the overall campaign was successful, filling the remaining diversity gaps requires more targeted outreach. The interests of renters, particularly those in rent-regulated units and NYCHA developments, will be better served by increased representation. The Borough President also remains focused on seating members ages 16-18, as well as new immigrant populations. Brooklyn's board members have bachelor's degrees at rates 1.5 times of the average resident, creating a void and noticeable lack of expertise on matters in the construction, retail, and trade industries. The pandemic highlighted the critical role of essential workers, many of them blue collar with low to moderate income; yet, their related interests are not represented. To fill the gaps, the Borough President's Office will partner with various organizations to spread awareness of the importance of community boards and encourage applications from residents who may not have considered joining a community board.

The application's demographic section was intended to bring everyone's interests into the room when members discuss their Brooklyn. This information not only guides issues that come to the boards, but also supports the Borough President's Comprehensive Plan, which addresses decades-long disparities in housing, transportation, and public health. With each board representing up to 250,000 residents, there is no shortage of issues to bring to the table.

As the 2023-2025 cohort of community board members take their seats in New York City's most grassroots form of government, the work continues towards building a better Brooklyn for all.


