PRESENTATION

FloodNet NYC is a collaborative program among the Mayor's Office of Climate and Environmental Justice, CUNY and NYU universities. The program aims to develop widespread, real-time urban flood monitoring in New York City. The initiative in conjunction with the Department of Environmental Protection (DEP) places sensors throughout the city. The sensors collect data about flood risk to be used to build flood resilience. The data is accessible to residents, community-based organizations, government agencies and researchers. FloodNet is actively seeking community input for sensor locations.

PUBLIC HEARING

Prospect Park Alliance represented by Jillian Pagano and XXX presented four (4) proposals, for recommendations to the Landmarks Preservation Commission and the Public Design Commission. The proposals were reviewed by Community Boards 6,7,8,9 and 14 prior to being presented to the Borough Board.

i. **Lincoln Road Playground Restoration**

Proposal to restore the 20, 000 square foot Lincoln Road Playground to include new play equipment and climbing structures, a water play area, new safety surfacing, shaded seating areas, an accessible sensory planter, and renovated pathways surrounding the playground.

ii. **Fallkill Falls Pathway Improvements**

Proposal to add new lighting and a handrail along a woodland pathway that connects Center Drive at the Nethermead Lawn to the Long Meadow Ballfields along the Fallkill Falls.

iii. **Picnic House Reconstruction**

Proposal to repair the historic 1920s Picnic House, including restoring exterior and interior stonework, brickwork and windows; and updating interior lighting, finishes and electrical wiring.

iv. **Wayfinding in the Vale**

Proposal to create a comprehensive master plan for a new signage system in the park that will provide wayfinding, stewardship and interpretive signage to improve access and the visitor experience.

Chair called for a roll call to prove quorum. Quorum was established.

Motion: Chair Baptiste moved to recommend that the Borough Board offer no objection to the four proposed capital projects presented by Prospect Park Alliance; seconded by Rep. Malloy. ***Passes 8-0-3***

i. Expiration of Open Meetings Law Hybrid Provision

ii. Borough Board's Bylaws Committee
